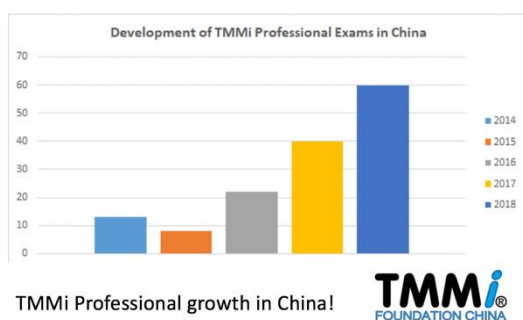


TMMi Local Chapter Meeting in Berlin
